Water and Hydro revenues are down due to drought and lack of ETO incentive payment in 2026. Legal and gas budget is over but expected.

E. Water and Hydro Report

- Meter Repairs- ongoing as new meters are needed to be repaired. So far all repairs are being done in house.
- Operations & Maintenance /Operational Technology/McKenzie Hydro - ongoing troubleshooting being done with the flow meters at the diversion. McKenzie hydro has a bearing repair taking place. Watson Hydro's scada screen is currently being assessed and we are waiting on a quote.

F. Updates

- HCP- 5 year review almost complete
- Solar- Not moving forward currently due to lack of funding. We will consider lease/rental agreement option instead.
- Wells – WaterSMART Grant Update has been completed and sent, Ellington will send out grant details to the BOD
- Operational Technology -Ellington working on a dashboard to help with forecasting and patterns. Thalacker suggests a ride along with the water master to see Tumalo sight.

Surplus- CatD8t has been listed as of May 27th, the scraper will be listed for \$4,000 OBO and the rest of the declared surplus will be listed at the end of the week.

H. Water User's Comments and Concerns

Netter put together a possible 5-member board division on paper and would like to put the option to a vote of the patrons. He believes it would help the district and that patrons would be for the expansion. He would like an election in November. Rognlien questions why a 5-member board and prefers a 3-member board. He also has praises for TSID handling of water delivery during the extreme drought year. Thalacker and Elwing have concerns with the complexity it would bring and the difficulty in finding board members to run. No decision made. A map is being created to show the entire district. It should be completed next month.

I. Board Member Comments

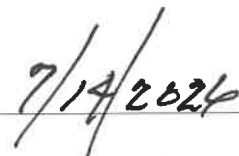
